This matter came before the Court on September 17, 2014, for a hearing pursuant to Timothy C. Holmseth's petition for a harassment restraining order against Rhonda W. Callahan (Polk Court File #60-CV-14-1528).

Petitioner Timothy C. Holmseth personally appeared pro se.

Respondent Rhonda W. Callahan personally appeared with her attorney, Mike Mattocks.

At the hearing, the parties agreed to dismiss the Polk harassment case and replace it with a protective order in their child support file (the present case). In particular, the protective order sets limits on Ms. Callahan's use and dissemination of Mr. Holmseth's financial information.

Based upon the agreement reached, IT IS ORDERED:

Confidentiality. Any and all financial discovery received by Ms. Callahan's
attorney of record shall be treated as confidential. The use and disclosure of
confidential information shall be confined to what is reasonably necessary to the
effective pursuit of Ms. Callahan's claims. ALL OTHER USE AND DISCLOSURE BY

MS. CALLAHAN AND HER COUNSEL DURING THE PENDENCY OF THIS ACTION OR AFTER ITS TERMINATION IS HEREBY PROHIBITED.

2. <u>Nondisclosure.</u> Unless agreed to in writing between both parties or permitted by further order of the court, Ms. Callahan's counsel of record may NOT provide copies of the discovery to Ms. Callahan or disseminate the information in any way (including online / social media dissemination) to nonparties (including parties in Mr. Holmseth's unrelated federal litigation). However, Ms. Callahan's counsel MAY SHOW the discovery to Ms. Callahan for purposes of case preparation. Ms. Callahan is also prohibited from disseminating said information in any way (including online / social media dissemination) to nonparties (including parties in Mr. Holmseth's unrelated federal litigation).

Ms. Callahan's attorney MAY ONLY disclose such information to the following persons and under the following conditions:

- a. To counsel's regularly employed support staff, including paralegal and clerical personnel, engaged in the conduct of this action as well as any experts who are hired by counsel to assist in this case (all of whom are subject to the same nondisclosure provisions set forth herein); and
- To the District Court and court personnel in the normal course of conducting hearings and filing documents.
