INVESTIGATOR FROM INDIANA CALLS ABOUT TIM HOLMSETH COMPLAINING THAT HE IS HARASSING HER THROUGH SEVERAL DIFFERENT MEANS. HER COMPLAINTS ARE CIVIL IN NATURE AND SHE WAS TOLD TO SUE HIM CIVILLY FOR PUBLISHING HER PRIVATE PHONE NUMBERS ETC ON THE INTERNET. SHE ALSO CLAIMS THAT HOLMSETH TOLD HER THAT HE HAS HALIEGH CUMMINGS IN HER APARTMENT. WHAT HE ACTUALLY SAID WAS "HALEIGH IS ALIVE AND YOU WOULDN'T BELIEVE WHO IS IN THE APARTMENT WITH ME RIGHT NOW" INSINUATING THAT HE HAD HALEIGH IN HIS APARTMENT.

OFFICERS RESPOND TO CONFIRM/DENY THAT HALEIGH IS PRESENT, WHICH OF COURSE SHE IS NOT. HOLMSETH ALONE WITH ONLY HIS TWO CHILDREN, CLAIMS CALLER MISINTERPRETED WHAT HE SAID AND HE WAS EXPECTING US.
